**ISSUE OF GOLDPHYRE RESOURCES LIMITED SECURITIES – SECONDARY TRADING NOTICE  
NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001  
("ACT")**

On 22 July 2016, Goldphyre Resources Limited ("**Company**") issued 1,820,000 fully paid ordinary shares ("**Securities**") upon exercise of \$0.08 listed options, expiring 30 September 2016.
